- Full implementation of the key Bologna instruments
- Modern quality assurance procedures based on ESG 2015
- Internal and external students mobility (Erasmus+ KA1, bilateral agreements)



#### Law "On Higher Education"

#### Article 7. Documents on higher education (academic degrees)

8. Shall the person graduate from study programmes delivered by higher education institutions, including foreign ones, these higher education institutions have the right to produce and issue joint degrees according to the template commonly decided upon by their academic councils

## Article 75. Key directions for international cooperation in the field of higher education


7) Establishing joint academic and research programmes with foreign higher education institutions, research organizations, other institutions

#### **Double Degree Programme**

Based on establishing correspondence between and synchronizing study programmes of partner higher education institutions (HEIs); characterized by mutual commitments of the parties involved in regard to the goals of the programme, study plan, organization of the learning process, and qualifications to be awarded.

- 1. Joint development and approval of study programme.
- 2. Conducting part of programme at partner HEI.
- 3. Automatic recognition of periods of study and learning outcomes from partner

HEI.

- 4. Participation of faculty members in the learning process of partner HEI within the framework of the given programme.
- 5. Awarding qualification at both partner HEIs.

For Master and PhD programmes - automatic recognition of the previous



#### DD programme – model 1 (1st cycle)

Tipical 4-year first degree programme

- 1<sup>st</sup> and 2<sup>nd</sup> year study at Ukrainian university
- 3<sup>rd</sup> year study at Partner university
- 4<sup>th</sup> year at Ukrainian university
- Mutual recognition of field placement (especially in engineering

and similar specialties)

- Agreed bachelor thesis/diploma work, two supervisors



#### DD programme – model 2 (2<sup>nd</sup> cycle)

Tipical 1.5 year second cycle programme

- Mutual recognition of Bachelor degree
- 1st and 3rd semesters study at Ukrainian university
- 2<sup>nd</sup> semester study at Partner university
- Agreed master thesis, two supervisors
- Partner participation in thesis defence



#### DD programme – model 3 (2<sup>nd</sup> cycle)

1 - 1.5 year second cycle programme(Master of Engineering in Measuring Technology)

- Mutual recognition of Bachelor degree
- 1<sup>st</sup> and 2<sup>nd</sup> semesters study at Partner university
- 3<sup>rd</sup> semester study at Ukrainian university
- Agreed master thesis, two supervisors
- Partner participation in thesis defence



#### DD programme – model 4 (2<sup>nd</sup> cycle)

1 - 1.5 year second cycle programme(Master of Economics in Accounting and Audit)

Mutual recognition of Bachelor degree

1<sup>st</sup> and 2<sup>nd</sup> semesters – study at Ukrainian university

3<sup>rd</sup> semester – study at Partner university

Agreed master thesis, two supervisors

Partner participation in thesis defense
